The painted finish and fabric "Colorfastness" is warranted for a period of seven years from the date of installation.

*The BlindGuyz LLC* will service all warranty work during regular business hours from 8:00 am to 3:00 pm start time, Mon-Fri excluding holidays. For the first 90 (ninety) days after installation of product, any warranty issue will be repaired or replaced at the place of original installation at no charge. After the first 90 (ninety) days from date of installation, and for as long as original purchaser owns the product, with proof of purchase, resides at the location for which the product was purchased and installed, any warranty issue will be repaired or replaced with like or similar materials to manufacturers original specifications. **IT IS THE CUSTOMERS RESPONSIBILITY** to return product to the Manufacturer or its authorized service agent for all warranty work. Pick up service may be arranged. Standard trip charges will apply. Shipping charges are not included.
